I understand that Bass Emporium will retain a 20% commission for this service. "Desired sale price" and "lowest acceptable sale price" are gross sale amounts and the commission fee will be deducted from the proceeds of the sale. All funds are to be paid to Bass Emporium by the purchaser and I understand that payment to me will not be made until checks and credit card transactions are cleared and the purchaser has completed the optional 72-hour approval period. Any repairs or adjustments deemed necessary to make the merchandise salable are noted below with an estimate of cost. The cost of these repairs or adjustments will also be deducted from the proceeds of the sale.

I understand that Bass Emporium will be advertising the above item on the internet and any other means necessary to sell my item and I will therefore refer all future inquiries to Bass Emporium. I agree to leave the above item at Bass Emporium for a minimum of 120 days. If I elect to pick up the item before the 120 day period I agree to pay Bass Emporium a 5% listing fee of the "Desired \$" to cover all advertising and processing costs.

I understand that this merchandise is not insured by Bass Emporium and that Bass Emporium is not responsible for loss due to fire, theft or damage. I certify that this merchandise is free and clear of all encumbrances whatsoever and is not being used as security or collateral for any loan or debt and I further state that I am the sole owner of the merchandise. I agree to hold Bass Emporium free from any claims arising from the sale of this merchandise now and at any time in the future.
